All publications will respect the ownership and authorship of the workshop participants, ensuring: (i) Personal data is not disclosed but anonymised; (ii) Profiling data is used only in aggregated form to prevent identification of individual participants.

Data will be retained for a period of 5 years following the end of the project to allow for comprehensive analysis, reporting, and publication related to the scope of the OPENVERSE project.
